

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Cambanay, Danao City, Cebu

26 January 2025, 6PM

I. Situation Overview

On 05 December 2023 at around 10:18 PM, a fire incident occurred at Sitio Pangdan, Brgy. Cambanay, Danao City, Cebu. The fire was declared out at around 11PM.

One (1) family or five (5) persons were affected in Brgy. Cambanay, Danao City, Cebu (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **five (5) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Cambanay, Danao City, Cebu** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱20,717.00** worth of assistance was provided to the affected family; of which, **₱8,717.00** from **DSWD** and **₱12,000.00** from the **Local Government Unit (LGU)** (see Annex D).
