1. Standby Funds

DSWD FO VII through its Municipal Action Team (MAT) provided FFPs to the affected family during the conduct of assessment in coordination with the MSWDO of the LGU of Garcia Hernandez, Bohol.

c. Other Activities

DATE	ACTIVITIES
01 August 2023	 DSWD FO VII assured the LGU of augmentation support upon their request. The affected family was referred to the Social Welfare and Development (SWAD) of DSWD FO VII in Bohol for assessment and possible provision of financial assistance through the Assistance to Individuals in Crisis Situations (AICS).

The Disaster Response Operations Monitoring and Information Center (DROMIC) of DSWD-DRMB is closely coordinating with DSWD FO VII for significant disaster response updates and assistance provided.
