

## DSWD DROMIC Report on the Fire Incident in Brgy. Luyan, Mapandan, Pangasinan

26 August 2023, 6PM

### I. Situation Overview

On 12 August 2023 at around 9:50 PM, a fire incident occurred in Brgy. Luyan, Mapandan, Pangasinan. According to the Bureau of Fire Protection (BFP), the fire was primarily caused by an improperly discarded cigarette butt.
