

## DSWD DROMIC Report on the Fire Incident in Brgy. Poblacion, Tapaz, Capiz, 23 August 2023, 6PM

### I. Situation Overview

On 23 April 2023 at around 10:30 PM, a fire incident occurred at a private commercial space along Roosevelt St., Brgy. Poblacion, Tapaz, Capiz. According to the Bureau of Fire Protection (BFP), the fire was caused by electrical short circuit and it was declared out at around 12:40 AM the next day.
