

# DSWD DROMIC Terminal Report on the Armed Conflict in Brgy. Cagbigajo, Pambujan, Northern Samar

13 November 2023, 6PM

## I. Situation Overview

On 22 July 2023 at around 12:55 PM, an armed conflict transpired at Sitio Badulan, Brgy. Cagbigajo, Pambujan, Northern Samar between the troops of the Philippine Army and members of the Communist Party of the Philippines-New People's Army (CPP-NPA).
