## DSWD DROMIC Terminal Report on the Armed Conflict on Brgy. Limulan Kalamansig, Sultan Kudarat 06 February 2024, 6AM

### I. Situation Overview

On 27 July 2023 at around 10:00 AM, a crossfire between Philippine Army and an unknown armed group occurred at Sitio Midsaker, Brgy. Limulan, Kalamansig, Sultan Kudarat.

A total of **29 families** or **88 persons** were affected in **Brgy. Limulan, Kalamansig, Sultan Kudarat** (see Annex A).

### III. Status of Displaced Population

#### Outside Evacuation Center

A total of **29 families** or **88 persons** temporarily stayed with their relatives or friends (see Annex B).

### IV. Cost of Humanitarian Assistance Provided

A total of **₱78,312.00** worth of assistance was provided to the affected families; of which, **₱43,512.00** from **DSWD** and **₱34,800.00** from the **Local Government Unit (LGU)** (see Annex C).
