





DSWD DROMIC Terminal Report on the Fire Incident in Brgy. 650, Port Area, Manila City

22 November 2023, 6PM

I. Situation Overview

On August 5, 2023, a fire incident occurred in Brgy. 650, Port Area, Manila City. The fire ignited at 4:59 in the afternoon and was officially declared extinguished at 8:14 PM. As per coordination with the Manila Department of Social Welfare Office (MDSWO), the fire incident affected 389 families, with corresponding 910 individuals.

Accordingly, displaced families chose to stay with their relatives in nearby areas thus, no evacuation center was established. All families have already returned to their original residences.

A total of ₱1,513,653.05 worth of assistance was provided by **DSWD** to the affected families (see Table 4).


