



DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Bulanao Centro, Tabuk City, Kalinga

22 November 2023, 6PM

I. Situation Overview

On August 19, 2023, at 7:45 PM, a fire incident transpired in Purok 6, Bulanao Centro, Tabuk City, Kalinga. The incident resulted in the complete destruction of a residential house causing displacement of a family with three (3) individuals who opted to stay with their relatives.. The community, along with the Bureau of Fire Protection – Tabuk City, promptly responded to the incident area hence, no casualties were reported.

As per information provided by the BFP Tabuk City, the assessed damage cost of the completely destroyed house amounts to Php 288,000.00.
