



DSWD DROMIC Report #1 on the Fire Incident at Arriola St., Brgy. Tejero, Cebu

as of 11 September 2023, 6PM

I. Situation Overview

On 10 September 2023 at around 8:04 PM, a fire incident occurred at Arriola St., Sitio Laurente, Brgy. Tejero, Cebu City. The fire was declared out at around 8:44 PM. Source: DSWD Field Office (FO) VII

II. Status of Affected Areas and Population

A total of **41 families** or **163 persons** are affected in **Brgy. Tejero, Cebu City** (see Table 1).

1. Standby Funds

- ₱27.82 million Quick Response Fund (QRF) at the DSWD Central Office.
- ₱5 million available at DSWD FO VII.

2. Prepositioned FFPs and Other Relief Items

- 128,381 FFPs available in Disaster Response Centers; of which, 99,603 FFPs are at the National Resource Operations Center (NROC), Pasay City, and 28,778 FFPs are at the Visayas Disaster Resource Center (VDRC), Mandaue City.
- 53,757 FFPs available at DSWD FO VII.
- ₱346.35 million worth of other FNIs at NROC, VDRC, and DSWD FO VII warehouses.
