

DSWD DROMIC Terminal Report on the Fire Incident at Sitio Laurente, Brgy. Tejero, Cebu

I. Situation Overview

On 10 September 2023 at around 8:04 PM, a fire incident occurred at Arriola St., Sitio Laurente, Brgy. Tejero, Cebu City. The fire was declared out at around 8:44 PM.

II. Status of Affected Areas and Population

A total of **49 families** or **186 persons** were affected in **Brgy. Tejero, Cebu City** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

A total of **49 families** or **186 persons** sought temporary shelter at the **Tejero Sports Complex** in **Brgy. Tejero, Cebu City** (see Annex B).

IV. Damaged Houses

A total of **13 houses** were **totally damaged** in **Brgy. Tejero, Cebu City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱2,630,929.00** worth of assistance was provided to the affected families; of which, **₱1,155,000.00** from **DSWD** and **₱1,475,929.00** from the **Local Government Unit (LGU)** (see Annex D).
