





DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Tambacan, Iligan City, Lanao Del Norte

27 November 2023, 6PM

I. Situation Overview

On August 14, 2023, an emergency call regarding a fire was received at the City Disaster Risk Reduction Management Office in Iligan City. Upon receiving the call, both their Ambulance and Firetrucks were promptly dispatched to Purok 2, Tambacan, Iligan City.

The Bureau of Fire Protection-Iligan reported that the fire escalated to a second alarm status at 01036H. By 1101, BFP-Iligan officially declared the fire extinguished, and the final declaration occurred at 1121H. Fortunately, there were no reported injuries or casualties in this incident.
