

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Tejero, Cebu City, Cebu

16 February 2024, 6AM

I. Situation Overview

On 28 September 2023 at around 1:30 PM, a fire incident occurred at Sitio Tewel and Seawall, Brgy. Tejero, Cebu City, Cebu. The fire was declared out at around 2:09 PM.

II. Status of Affected Areas and Population

A total of **62 families** or **236 persons** were affected in **Brgy. Tejero, Cebu City, Cebu** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

A total of **62 families** or **236 persons** sought temporary shelter at the **Tejero Elementary** in **Brgy. Tejero, Cebu City, Cebu** (see Annex B).

IV. Damaged Houses

A total of **22 houses** were damaged; of which, **20** are **totally damaged** and **two (2)** are **partially damaged** in **Brgy. Tejero, Cebu City, Cebu** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱2,929,014.00** worth of assistance was provided to the affected families; of which, **₱975,000.00** from **DSWD** and **₱1,954,014.00** from the **Local Government Unit (LGU)** (see Annex D).
