

DSWD DROMIC Report #1 on the Fire Incident in Brgy. Masara, Maco, Davao de Oro as of 17 October 2023, 6PM

I. Situation Overview

On 07 October 2023 at around 5:45 PM, a fire incident occurred at Zone 1, Brgy. Masara, Maco, Davao de Oro. Based on the investigation, it was determined that the fire was caused by a faulty electrical wiring. The fire was declared out at around 7PM.
