I. Situation Overview

On 27 September 2023 at around 5:06 AM, a fire incident occurred at Velpal Phase 21, Brgy. Pakigne, Minglanilla, Cebu. It was declared fire out at 5:31 AM.

1. Standby Funds

- ₱16.54 million Quick Response Fund (QRF) at the DSWD Central Office.
- ₱5 million available at DSWD FO VII.

2. Prepositioned FFPs and Other Relief Items

- 136,803 FFPs available in Disaster Response Centers; of which, 95,435 FFPs are at the National Resource Operations Center (NROC), Pasay City and 41,368 FFPs are at the Visayas Disaster Resource Center (VDRC), Mandaue City.

27 September 2023	<ul style="list-style-type: none"> The MSWDO of the LGU of Minglanilla, Cebu provided food packs and hygiene kits to the affected families and individuals. They were also provided cash assistance amounting to a total of ₱25,000.00.

c. Other Activities

18 October 2023	<ul style="list-style-type: none"> DSWD FO VII closely coordinated with the LGU of Minglanilla, Cebu for significant updates and any requests for relief augmentation. The affected families were referred to the Crisis Intervention Section (CIS) of DSW FO VII for assessment and possible provision of financial assistance through Assistance to Individuals in Crisis Situations (AICS).

The Disaster Response Operations Monitoring and Information Center (DROMIC) of DSWD-DRMB is closely coordinating with DSWD FO VII for significant disaster response updates and assistance provided.
