





# DSWD DROMIC Terminal Report on the Armed Conflict in Brgy. Canlusong, Enrique B. Magalona, Negros Occidental

16 December 2023, 6PM

## I. Situation Overview

On 17 October 2023 at around 5:15 PM, an armed conflict transpired between the troops of the 79th Infantry Battalion (IB) – Philippine Army and members of the Communist Terrorists Group – New People's Army (CTG-NPA) at Sitio Nabalas Dos, Brgy. Canlusong, Enrique B. Magalona, Negros Occidental.
