## I. Situation Overview

On 17 September 2023 at around 11:00 PM, a fire incident occurred in Brgy. Mantija, Danao City, Cebu.

## IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Mantija, Danao City, Cebu** (see Annex C).

## V. Cost of Humanitarian Assistance Provided

A total of **₱33,615.10** worth of assistance was provided to the affected families; of which, **₱23,615.10** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
