





# DSWD DROMIC Report #1 on the Effects of a Low Pressure Area (LPA) and Shear Line

as of 18 November 2023, 6PM

#### I. Situation Overview

On 16 November 2023, a landslide incident occurred in Brgy. Pong-on, Bontoc in the province of Southern Leyte due to the effects of LPA and Shear Line.

On 17 November 2023, the effects of LPA and Shear Line were also reported in the municipalities of Magarao, Camarines Sur, and San Miguel, Catanduanes.

Issued on 18 November 2023 at around 3:00 PM, the LPA was estimated based on all available data at 505 km East of Surigao City, Surigao del Norte (9.8°N, 130.1°E) and the Shear Line continuously affects the eastern section of Southern Luzon while the Northeast Monsoon continuously affects the rest of Luzon.




Figure 1. Areas affected by Shear Line and LPA.

A total of **994 families** or **2,352 persons** are affected in **14 barangays** in **Regions V and VIII** (see Annex A).

#### a. Inside Evacuation Center

There are seven (7) families or 28 persons currently taking temporary shelter at the Brgy. Pong-On Hall in Bontoc, Southern Leyte (see Annex B).
