



DSWD DROMIC Report on the Fire Incident in Brgy. Bagumbayan, Miagao, Iloilo

24 November 2023, 6PM

I. Situation Overview

On October 24, 2023, a fire incident occurred in Barangay Bagumbayan, Miagao, Iloilo. As reported by the Municipal Social Welfare and Development Office (MSWDO), the incident led to the displacement two (2) families, comprising eleven (11) individuals.

The Bureau of Fire Protection promptly responded to the scene to extinguish the fire. The incident resulted in the total damage of one (1) house and partial damage to another.
