

DSWD DROMIC Report on the Fire Incident in Brgy. Cabalitian, Sual, Pangasinan

27 November 2023, 6PM

I. Situation Overview

On 09 November 2023, a residential house located in Brgy Cabalitian, Sual, Pangasinan was gutted by fire wherein no belongings were saved. The caused of fire was from a faulty electrical wire.

In response to the incident, the Department of Social Welfare and Development (DSWD) and the Local Government Unit of Sual, Pangasinan has provided both relief and financial assistance to support immediate needs of the affected family. Additionally, the Municipal Social Welfare and Development Office has committed to addressing the immediate needs of the affected, while staying outside evacuation centers.
