

DSWD DROMIC Report on the Fire Incident in Brgy. Cabanbanan Oton, Iloilo

24 November 2023, 6PM

I. Situation Overview

On October 18, 2023, a fire incident occurred in Barangay Cabanbanan, Oton, Iloilo. According to the report from the Municipal Social Welfare and Development Office (MSWDO), the incident affected and displaced one (1) family, comprising three (3) individuals.

The Bureau of Fire Protection promptly responded to the scene to extinguish the fire, however, one (1) house was totally destroyed due to the incident caused by faulty electrical wirings.
