24 November 2023, 6PM

## I. Situation Overview

On November 1, 2023, at approximately 9:00 PM, a fire incident took place in Barangay Cagbang, Miagao, Iloilo. The Bureau of Fire Protection (BFP) – Miagao reported that the fire was purportedly caused by an unattended candle, leading to the displacement of a family consisting of two (2) individuals.
