### I. Situation Overview

On 09 October 2023 at around 10.40 PM, a fire incident occurred at Sto. Rosario, Upper Street, Brgy. Cahagnaan, Matalom, Leyte. According to the Bureau of Fire Protection (BFP), the fire was caused by faulty wirings. The fire was declared out on the same date with the immediate arrival of the Bureau of Fire Protection (BFP).
