





DSWD DROMIC Report on the Fire Incident in Brgy. Dalligan, Kiangan, Ifugao

27 November 2023, 6PM

I. Situation Overview

On October 30, 2023, at around 9 AM, a structural fire incident occurred in Brgy. Dalligan, Kiangan, Ifugao, leading to the displacement of two (2) families, comprising 11 individuals. The fire was attributed to the fireplace of one of the adjacent houses.

Currently, the displaced families have sought refuge with friends and relatives within the vicinity. In response to this situation, the Municipal Social Welfare and Development Office has committed to addressing the immediate needs of the affected families and individuals.
