

## DSWD DROMIC Report on the Fire Incident in Brgy. Labit, Villasis, Pangasinan

24 November 2023, 6PM

### I. Situation Overview

On 10 October 2023 at around 8:16 PM, a fire incident occurred at Zone 2, Brgy. Labit, Villasis, Pangasinan. According to reports, the cause of fire was due to an unattended gas stove. There are two (2) families or eight (8) individuals affected and their residence was declared partially damaged. Furthermore, the affected families continue to reside in their house despite the damage incurred.
