

DSWD DROMIC Report on the Fire Incident in Brgy. Pajo, Lapu-Lapu City, Cebu

26 November 2023, 6PM

I. Situation Overview

On October 8, at around 11:30 AM, a fire engulfed at Sitio Kitchen Paradise in Barangay Pajo, Lapu-Lapu City. The incident escalated to the first alarm status, prompting emergency response efforts to 14 displaced families' equivalent to 85 individuals. As reported, the fire was extinguished around 12:30 with no reported injuries or casualties however, the estimated cost of damage has reached Php 105,000.00

A total of **eight (8) families** or **55 persons** sought temporary shelter in **one (1) evacuation center** in **Pajo Gymnasiu** (see Table 2).
