

DSWD DROMIC Report on the Fire Incident in Brgy. Santa Teresa, Jordan, Guimaras

25 November 2023, 6PM

I. Situation Overview

On 26 October 2023 at around 3PM, a fire incident occurred in Brgy. Santa Teresa, Jordan, Guimaras. The fire destroyed one (1) house, resulting in the displacement of a family. According to the Bureau of Fire Protection (BFP) – Jordan, the cause of fire was allegedly due to an unattended candle. The fire out was declared at around 3:53 PM.
