



DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Tambacan, Iligan City, Lanao del Norte

11 February 2024, 6PM

I. Situation Overview

On 06 November 2023 at around 1:35 PM, a fire incident occurred at Purok 2, Brgy. Tambacan, Iligan City, Lanao del Norte.

Relative to the incident, the DSWD through its Field Office in Region X together with the LGU of Iligan City, Lanao del Norte, provided relief assistance to support the immediate needs of the affected families and individuals.

II. Status of Affected Areas and Population

A total of **47 families** or **128 persons** were affected in **Brgy. Tambacan, Iligan City, Lanao del Norte** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

A total of **47 families** or **128 persons** sought temporary shelter at the **Brgy. Tambacan Gymnasium** in **Brgy. Tambacan, Iligan City, Lanao del Norte** (see Annex B).

IV. Damaged Houses

A total of **29 houses** were damaged; of which, **27** are **totally damaged** and **two (2)** are **partially damaged** in **Brgy. Tambacan, Iligan City, Lanao del Norte** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P513,430.10** worth of assistance was provided to the affected families; composed of **P403,430.10** from **DSWD** and **P110,000.00** from the **Local Government Unit (LGU)** (see Annex D).
