On 23 December 2023 at around 10:10 AM, a fire incident occurred at Brgy. Gerona-Gimeno, Guimbal, Iloilo. The fire was declared out at around 11:38 AM.

There are **five (5) families** or **21 persons** currently taking temporary shelter at the **Barangay Hall** in **Brgy. Gerona-Gimeno, Guimbal, Iloilo** (see Annex B).

One (1) house was totally damaged (see Annex C).
