## I. Situation Overview

On 12 December 2023 at around 3:05 AM, a fire incident transpired at Brgy, 105, Happyland Tondo, Manila City. Said fire was declared fire out at around 6:59 AM.

There are 282 families or 1,098 persons currently taking temporary shelter in one (1) evacuation center in Brgy. 105, Happyland Tondo, Manila City (see Annex B).

A total of 169 houses were totally damaged in Brgy. 105, Happyland Tondo, Manila City (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **P194,268.10** worth of assistance from the **DSWD** was provided to the affected families (see Annex D).
