

# DSWD DROMIC Report #3 on the Armed Conflict in Brgy. Dalgan, Pagalungan, Maguindanao del Sur

as of 15 December 2023, 6PM

## I. Situation Overview

On 07 December 2023 at around 3:25 AM, an armed conflict transpired between the troops of Philippine Army and Dawlah Islamiya at Sitio Proper, Brgy. Dalgan, Pagalungan, Maguindanao del Sur. This event has led to the displacement of families and individuals in the area, along with substantial damage to residential structures.

## II. Status of Affected Areas and Population

A total of **724 families** or **3,620 persons** are affected in **Brgy. Dalgan, Pagalungan, Maguindanao del Sur** (see Annex A).

## III. Status of Displaced Population

### a. Inside Evacuation Center

There are **457 families** or **2,285 persons** currently taking temporary shelter in **two (2) evacuation centers** in **Brgy. Dalgan Covered Court** and **Dalgan Elementary School** (see Annex B).

### b. Outside Evacuation Center

There are **267 families** or **1,335 persons** temporarily staying with their relatives or friends (see Annex C).

### c. Total Displaced Population

There are **724 families** or **3,620 persons** displaced in **Brgy. Dalgan, Pagalungan, Maguindanao del Sur** (see Annex D).

## IV. Damaged Houses

A total of **15 houses** were **totally damaged** in **Brgy. Dalgan, Pagalungan, Maguindanao del Sur** (see Annex E).

## V. Cost of Humanitarian Assistance Provided

A total of **₱1,048,137.00** worth of assistance was provided by **DSWD** to the affected families (see Annex F).
