





DSWD DROMIC Report #6 on the Fire Incident in Brgy. Pusok, Lapu-Lapu City, Cebu

as of 23 December 2023, 6PM

I. Situation Overview

On 12 December 2023 at around 1:25 PM, a fire incident occurred at Sitio Sta. Maria, Brgy. Pusok, Lapu-Lapu City, Cebu which also affected nearby areas and resulted in the displacement of families and persons. The fire was declared out at around 4:57 PM.

On 14 December 2023, the Lapu-Lapu City Government, upon the recommendation of the Lapu-Lapu City Disaster Risk Reduction and Management Council, declared Sitio Sta. Maria in Brgy. Pusok under State of Calamity (SoC).

II. Status of Affected Areas and Population

A total of **2,202 families** or **5,151 persons** are affected in **Brgy. Pusok, Lapu-Lapu City, Cebu** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

There are **2,202 families** or **5,151 persons** currently taking temporary shelter in **two (2) evacuation centers** in **Brgy. Pusok**, **Lapu-Lapu City**, **Cebu** (see Annex B).

IV. Damaged Houses

A total of **581 houses** were damaged; of which, **577** are **totally damaged** and **four** (**4)** are **partially damaged** in **Brgy. Pusok, Lapu-Lapu City, Cebu** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱33,426,035.70 worth of assistance was provided to the affected families; of which, ₱15,951,035.70 from the DSWD and ₱17,475,000.00 from the Local Government Unit (LGU) (see Annex D).

1. Standby Funds

- ₱95.22 million Quick Response Fund (QRF) at the DSWD Central Office.
- ₱5 million available at DSWD FO VII.

2. Prepositioned FFPs and Other Relief Items

- 59,617 FFPs available in Disaster Response Centers; of which, 56,203 FFPs are at the National Resource Operations Center (NROC), Pasay City and 3,414 FFPs are at the Visayas Disaster Resource Center (VDRC), Mandaue City.
- 89,245 FFPs available at DSWD FO VII.
- ₱1 billion worth of other FNIs at NROC, VDRC, and DSWD FO VII warehouses.

b. Food and Non-food Items (FNIs)

18 December 2023	DSWD FO VII through the Regional Resource Operation Section (RROS) facilitated the pullout of 1,768 undistributed FFPs that were remained unclaimed due to non-availability of storage facility. Likewise, the unclaimed FFPs will be made available for distribution only upon the request of the LGU of Lapu-Lapu City.
16 December 2023	DSWD FO VII though its Disaster Response Management Division (DRMD) distributed additional FFPs to the affected families.
14 December 2023	DSWD FO VII distributed additional FNIs to the families and individuals affected by the fire incident.
12 December 2023	DSWD FO VII distributed FNIs to the families and individuals affected by the fire incident.

d. Other Activities

22 December 2023	 DSWD FO VII has an ongoing distribution of financial assistance amounting to a total of ₱11,693,565.00 through the Emergency Cash Transfer (ECT) program provided to 1,759 potential beneficiaries to respond to various relief and early recovery needs of those affected by the fire incident.







DATE	ACTIVITIES
	DSWD FO VII through the National Household Targeting System (NHTS) in coordination with the Philippine Statistics Authority, facilitated the Philippine Identification System (PhilSys) Registration for the affected individuals.
20 December 2023	DSWD FO VII in coordination with LGU Lapu-Lapu City, conducted consultation dialogue and social preparation with the beneficiaries relative to the implementation of Emergency Cash Transfer program. Additionally, a deduplication process was undertaken for the master list of beneficiaries.
17 December 2023	 DSWD FO VII coordinated with the City Social Welfare and Development Office (CSWDO) of Lapu-Lapu City for the transfer of the IDPs to a new evacuation center. DSWD FO VII maintained close coordination with the LGU of Lapu-Lapu City and other concerned offices for significant disaster response updates and further requests of relief augmentation.
