



DSWD DROMIC Report on the Diarrhea Outbreak in Talaingod, Davao del Norte

31 December 2023, 6PM

I. Situation Overview

On 16-30 September, 2022, 133 cases of watery diarrhea have been diagnosed with acute gastroenteritis in Sitio Kaylawan, Barangay Sto. Nino, Talaingod, Davao Del Norte with three (3) deaths. The case spreaded to its 12 other sitios, simultaneously the same health problem occurred in the 9 sitios of Barangay Palma Gil and 1 sitio of Barangay Dagohoy.

As of October 21, 2022, a total of 266 cases with a total of eight (8) deaths were reported. Of the total 266 cases, 122 are male and 144 are female. The affected children are 77 males and 83 females.

Diarrhoeal disease or Diarrhea is defined as the passage of three or more loose or liquid stools per day (or more frequent passage than is normal for the individual). Frequent passing of formed stools is not diarrhea, nor is the passing of loose, "pasty" stools by breastfed babies. Diarrhea is usually a symptom of an infection in the intestinal tract, which can be caused by a variety of bacterial, viral, and parasitic organisms. Infection is spread through contaminated food or drinking-water, or from person-to-person due to poor hygiene.

II. Status of Affected Areas and Population

A total of **1,168 families** or **5,139 persons** were affected in **three (3) barangays** in **Talaingod, Davao del Norte.** (see Annex A).

III. Cost of Humanitarian Assistance Provided

A total of **₱2,377,797.03** worth of assistance was provided to the affected families; of which, **₱756,630.40** from **DSWD** and **₱1,621,166.63** from the **Local Government Unit (LGU)** (see Annex B).
