11 December 2023, 6PM

I. Situation Overview

On 05 August 2023 at 6:00 PM, a fire broke out in Purok Sangil, Brgy. Binabag, Pinamungajan, Cebu.

II. Status of Affected Areas and Population

One (1) family or four (4) persons were affected in Brgy. Binabag, Pinamungajan, Cebu (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or four (4) persons are temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in **Brgy. Binabag**, **Pinamungajan**, **Cebu** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱12,293.00 worth of assistance was provided to the affected family; of which, ₱9,293.00 from DSWD and ₱3,000.00 from the Local Government Unit (LGU) (see Annex D).
