





DSWD DROMIC Report on the Fire Incident in Brgy. Central, Mati City, Davao Oriental Province

I. Situation Overview

On 08 February 2020 at around 11:30 AM, a fire incident occurred at Purok Masagana 9 Andavel, (Sto. Nino, Sampalok), Brgy. Central, Mati City, Davao Oriental Province.

II. Status of Affected Areas and Population

A total of **80 families** or **286 persons** were affected in **Brgy. Central**, **Mati City**, **Davao Oriental Province**. (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

A total of **80 families** or **286 persons** sought temporary shelter in **one (1) evacuation center** in **Brgy. Central, Mati City, Davao Oriental Province.** (see Annex B).

IV. Damaged Houses

A total of **55 houses** were damaged; of which, **two (2)** are **totally damaged** and **53** are **partially damaged** in **Brgy. Central, Mati City, Davao Oriental Province.** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱392,198.61** worth of assistance was provided by **DSWD** to the affected families. (see Annex D).
