I. Situation Overview

On 22 August 2023 at around 5:00 AM, a fire incident occurred in Brgy. Masulog, La Castellana, Negros Occidental. The fire engulfed one (1) house, resulting in the displacement of a family. The fire was officially declared extinguished at 6:10 AM.
