## DSWD DROMIC Report on the Fire Incident in Brgy. Pandayan, Meycauayan, Bulacan

### I. Situation Overview

On 20 August 2023, a fire incident occurred in Brgy. Pandayan, Meycauayan, Bulacan

A total of **nine (9) families** or **52 persons** were affected in **Brgy. Pandayan, Meycauayan, Bulacan** (see Annex A).

### III. Damaged Houses

A total of **six (6) houses** were **totally damaged** in **Brgy. Pandayan, Meycauayan, Bulacan** (see Annex B).

### IV. Cost of Humanitarian Assistance Provided

A total of **₱97,187.50** worth of assistance was provided to the affected families of which, **₱69,178.50** from **DSWD** and **₱28,000.00** from the **Local Government Unit (LGU)** (see Annex C).
