





DSWD DROMIC Report on the Fire Incident in Brgy. Quirino, Gen. MacArthur, Eastern Samar

23 December 2023, 6PM

I. Situation Overview

On 31 October 2023 at around 11:00 PM, a fire incident occurred at Brgy. Quirino, MacArthur, Eastern Samar. The fire was declared out at around 1:00 AM on November 1, 2023.

In response, the Department of Social Welfare and Development through its Field Office in Region VIII, assessed the situation and promptly intervened to support the immediate needs of the affected families and individuals by providing relief and financial assistance.

A total of **four (4) families** or **18 persons** were affected in **Brgy. Quirino, Macarthur, Eastern Samar** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **four (4) families** or **18 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of four (4) house was totally damaged Brgy. Quirino, Macarthur, Eastern Samar (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P82,520.44** worth of assistance was provided **by DSWD** to the affected families. (see Annex D).
