I. Situation Overview

On 09 November 2023 at around 5:46 PM, a fire incident occurred in Brgy. Sablogon, Passi City, Iloilo.

A total of **two (2) families** or **nine (9) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **two (2) houses** were **totally damaged** in **Brgy. Sablogon, Passi City, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P11,172.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
