



DSWD DROMIC Report on the Fire Incident in Brgy. Taloto-an, Concepcion, Iloilo

02 December 2023, 6PM

I. Situation Overview

On 15 November 2023 at around 5:30 AM, a fire incident occurred in Brgy. Taloto-an, Concepcion, Iloilo which affected and displaced one (1) family or five (5) individuals.

The Bureau of Fire Protection (BFP) responded to the scene and investigated the incident. The fire was caused by an open flame from a liquified petroleum gas (LPG) with a defective regulator. The displaced family temporarily stayed with their relatives.

II. Status of Affected Areas and Population

One (1) family or five (5) persons were affected in Brgy. Taloto-an, Concepcion, Iloilo (see Annex A).

III. Damaged Houses

One (1) house was totally damaged in **Brgy. Taloto-an, Concepcion, Iloilo** (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of **₱5,500.00** worth of assistance was provided by **DSWD** to the affected families (see Annex C).
