I. Situation Overview

On 07 August 2023 at around 3:00 PM, a fire broke out in Purok 1, Brgy. Tupas, Pinamungajan, Cebu.

One (1) house was totally damaged in **Brgy. Tupas, Pinamungajan, Cebu** (see Annex D).

V. Cost of Humanitarian Assistance Provided

A total of ₱11,763.00 worth of assistance was provided to the affected family; of which, ₱8,763.00 from DSWD and ₱3,000.00 from the Local Government Unit (LGU) (see Annex E).
