## **DSWD DROMIC Report on the Fire incident in Brgy. Caingin, Iloilo City**

20 December 2023, 6PM

### **I. Situation Overview**

On 04 November 2023 at around 12:30 AM, a fire incident occurred in Brgy. Caingin, La Paz, Iloilo City resulted in the displacement of families and damage to property.

### **IV. Damaged Houses**

A total of **three (3) houses** were **totally damaged** in **Brgy. Caingin, Iloilo City** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱19,704.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
