

DSWD DROMIC Terminal Report on the Armed Conflict in Datu Hoffer Ampatuan, Maguindanao del Sur

12 February 2024, 6PM

I. Situation Overview

On 01 December 2023 at around 12:30 PM, an armed conflict transpired between the combined force of the Operating Unit of 2LRC-JSOU8 and 601Bde Philippine Army (PA) against Dawla Islamiyah (DI) - Philippines led by Abdulra Sapal, also known as “Bro Sapal” at Sitio Pamibingan, Brgy. Tuayan Mother, Datu Hoffer Ampatuan, Maguindanao del Sur.

II. Status of Affected Areas and Population

A total of **81 families** or **405 persons** were affected in **two (2) barangays** in **Datu Hoffer Ampatuan, Maguindanao del Sur** (see Annex A).

III. Status of Displaced Population

a. Inside Evacuation Center

A total of **34 families** or **170 persons** sought temporary shelter at the **Brgy. Limpongo Evacuation Center** in **Datu Hoffer Ampatuan, Maguindanao del Sur** (see Annex B).

b. Outside Evacuation Center

A total of **47 families** or **235 persons** temporarily stayed with their relatives or friends (see Annex C).

c. Total Displaced Population

A total of **81 families** or **405 persons** were displaced in **Datu Hoffer Ampatuan, Maguindanao del Sur** (see Annex D).

IV. Cost of Humanitarian Assistance Provided

A total of **₱75,210.00** worth of assistance was provided by **DSWD** to the affected families (see Annex E).
