



DSWD DROMIC Terminal Report on the Armed Conflict in Maguindanao del Sur

15 January 2024, 6PM

I. Situation Overview

On 17 December 2023 at around 1:00 AM, an armed conflict transpired in Mamasapano and Shariff Saydona Mustapha, Maguindanao del Sur between two (2) Moro Islamic Liberation Front (MILF) factions. This event led to the displacement of families and individuals in the affected area and nearby barangays.

II. Status of Affected Areas and Population

A total of **1,605 families** or **8,025 persons** were affected in **four (4) barangays** in **Maguindanao del Sur** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

There are **1,605 families** or **8,025 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of **₱2,590,965.00** worth of assistance was provided by **DSWD** to the affected families (see Annex C).
