





DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Aguisan, Himamaylan City, Negros Occidental

23 December 2023, 6PM

I. Situation Overview

On 13 December 2023 at around 1:00 PM, a fire incident transpired in Brgy. Aguisan, Himamaylan City, Negros Occidental. The fire was declared fire out at around 2:55 PM.

In response, the Department of Social Welfare and Development through its Field Office in Region VI, together with the Local Government Unit of Himamaylan City assessed the situation and promptly intervened to support the immediate needs of the affected families and individuals.

II. Status of Affected Areas and Population

A total of four (4) families or eleven (11) persons were affected in Brgy. Aguisan, Himamaylan City, Negros Occidental (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family equivalent to four (4) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of four (4) houses were damaged, of which, one (1) was totally damaged and three (3) were partially damaged in Brgy. Aguisan, Himamaylan City, Negros Occidental (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P36,572.00** worth of assistance was provided to the affected families; of which, **P31,572.00** from **DSWD** and **P5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
