

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. BF Homes, Parañaque City

19 February 2024, 6AM

I. Situation Overview

On 05 December 2023 at around 3:53 PM, a fire incident occurred at Ipil Side, Purok 4, Brgy. BF Homes, Parañaque City. The fire was declared out at around 6:31 PM.

Relative to the incident, the DSWD through its Field Office in the National Capital Region, provided relief augmentation to support the immediate needs of the affected families and individuals.

II. Status of Affected Areas and Population

A total of **54 families** or **185 persons** were affected in **Brgy. BF Homes, Parañaque City** (see Annex A).

III. Status of Displaced Population

a. Inside Evacuation Center

A total of **31 families** or **178 persons** sought temporary shelter in an evacuation center and have returned in their place of residence in **Brgy. BF Homes, Parañaque City** (see Annex B).

b. Outside Evacuation Center

A total of **23 families** or **7 persons** temporarily stayed with their relatives or friends (see Annex C).

c. Total Displaced Population

A total of **54 families** or **185 persons** were displaced in **Brgy. BF Homes, Parañaque City** (see Annex D).

IV. Damaged Houses

A total of **37 houses** were **totally damaged** in **Brgy. BF Homes, Parañaque City** (see Annex D).

V. Cost of Humanitarian Assistance Provided

A total of **₱256,386.06** worth of assistance was provided by **DSWD** to the affected families (see Annex E).
