I. Situation Overview

On 29 December 2023 at around 4:13 AM, a fire incident occurred at Mayor Jaldon St., Brgy. Canelar, Zamboanga City. The fire was declared out at around 5:30 AM.

A total of **₱22,181.50** worth of assistance was provided by **DSWD** to the affected families (see Annex C).
