





DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Commonwealth, Quezon City

19 February 2024, 6AM

I. Situation Overview

On 11 December 2023 at around 3:42 AM, a fire incident transpired at Purok 3 and 4, Upper Nawasa, Barangay Commonwealth, Quezon City, and was successfully extinguished by 5:47 AM.

Following the incident, the Social Services Development Department of the Quezon City Local Government Unit assessed the incident and reported a total of 66 families, comprising 178 individuals, were affected. The Purok 3 Covered Court in Upper Nawasa served as an evacuation center for these families, who have already returned to their habitual residences.

Relative to the incident, the DSWD through its Field Office in the National Capital Region, provided relief augmentation to support the immediate needs of the affected families and individuals.

A total of **66 families** or **178 persons** were affected in **Brgy. Commonwealth**, **Quezon City** (see Annex A).

Inside Evacuation Center

A total of **66 families** or **178 persons** sought temporary shelter at the **Purok 3 Covered Court** in **Brgy. Commonwealth, Quezon City** (see Annex B).

IV. Damaged Houses

A total of **50 houses** were **totally damaged** in **Brgy. Commonwealth, Quezon City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱309,800.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
