





DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Gerona-Gimeno, Guimbal, Iloilo

11 February 2024, 6AM

I. Situation Overview

On 23 December 2023 at around 10:10 AM, a fire incident occurred at Brgy. Gerona-Gimeno, Guimbal, Iloilo. The fire was declared out at around 11:38 AM.

Relative to the incident, the DSWD through its Field Office in Region VI, provided intervention to support the immediate needs of the affected families and individuals by means of relief assistance.

A total of five (5) families or 21 persons were affected in Brgy. Gerona-Gimeno, Guimbal, Iloilo (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

A total of five (5) families or 21 persons sought temporary shelter in Brgy. Hall of Gerona-Gimeno, Guimbal, Iloilo (see Annex B).

IV. Damaged Houses

A total of **one (1) house** were totally damaged in **Brgy. Gerona-Gimeno, Guimbal, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱34,855.00 worth of assistance was provided to the affected families from the **DSWD** (see Annex D).
