



# DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Tagnipa, Maasin, Southern Leyte

15 February 2024, 6AM

# I. Situation Overview

On 23 December 2023 at around 1:05 PM, a fire incident occurred in Brgy. Tagnipa, Maasin, Southern Leyte. The fire was declared out at around 2:40 PM.

# **II.** Status of Affected Areas and Population

A total of **30 families** or **101 persons** were affected in **Brgy. Tagnipa, Maasin, Southern Leyte** (see Annex A).

### III. Status of Displaced Population

- a. Inside Evacuation Center
   A total of eight (8) families or 47 persons sought temporary shelter at the Maasin Central School in Brgy. Tagnipa, Maasin, Southern Leyte (see Annex B).
- b. Outside Evacuation Center
   A total of 22 families or 54 persons are temporarily staying with their relatives or friends (see Annex C).
- c. Total Displaced Population
   A total of 30 families or 101 persons were displaced in Brgy. Tagnipa, Maasin, Southern (see Annex D).

#### IV. Damaged Houses

A total of **30 houses** were damaged; of which, **25** are **totally damaged** and **five (5)** are **partially damaged** in **Brgy. Tagnipa, Maasin, Southern** (see Annex E).

### V. Cost of Humanitarian Assistance Provided

A total of **₱1,882,787.70** worth of assistance was provided to the affected families; of which, **₱537,787.70** from **DSWD** and **₱1,345,000.00** from the **Local Government Unit (LGU)** (see Annex F).
