# I. Situation Overview

On 08 January 2024 at around 4:30 PM, a fire incident occurred at Purok 23-C, Catleya St., Brgy. 76-A Bucana, Davao City.

#### **Inside Evacuation Center**

There are **16 families** or **64 persons** currently taking temporary shelter at the **SIR Phase I Covered Court** in **Brgy. 76-A Bucana, Davao City** (see Annex B).

## IV. Damaged Houses

A total of 13 houses were damaged; of which, 11 are totally damaged and two (2) are partially damaged in Brgy. 76-A Bucana, Davao City (see Annex C).
